Introduction

1. Acceptance of Terms

By registering, accessing, or using PicklePot, you accept and agree to be bound by these Terms. If you do not agree, do not use the app.

2. Eligibility

You must be at least 13 years old, or the legal age of majority in your jurisdiction, to use the app.

3. License Grant

We grant you a limited, non-exclusive, revocable license to use PicklePot for personal, non-commercial purposes.

4. User Obligations

You agree not to:

- Use the app for unlawful purposes.
- Attempt to hack, reverse-engineer, or disrupt the app.
- Share false or misleading information.
- Infringe on intellectual property rights of others.

5. Match Data & Gameplay

Users are responsible for the accuracy of submitted scores, rankings, and gameplay records. We disclaim liability for disputes arising from user-submitted data.

5A. Tournaments & Organizer Responsibilities (New)

- User Verification: It is the responsibility of the user/participant to verify and trust the tournaments they choose to participate in. Pickleball Compete LLC does not guarantee the legitimacy, quality, or outcomes of any tournament or organizer.
- Organizer Authenticity: Organizers are solely responsible for the pots they create and for ensuring that all information they provide (including tournament details, schedules, locations, fees, and rules) is truthful, accurate, and up to date.
- Required Organizer Contact: Organizers must provide a valid organizer email so participants can contact them regarding their tournaments. Failure to maintain a reachable organizer email may result in removal or suspension of the related pot.
- Correct Tournament Info: It is the organizer's responsibility to input correct information for their tournaments, including (as applicable) date/time, venue address, city, state, zip code, accepted payment methods (Zelle/Cash App/Onsite/Stripe when enabled), and any participation requirements.
- Independence from PicklePot: Organizers act independently and are not agents, employees, or representatives of Pickleball Compete LLC. Any issues or disputes regarding a tournament

(including refunds, delays, or cancellations) must be resolved directly with the organizer.

6. Payments & Subscriptions

Payments are processed securely by third-party providers (e.g., Stripe). Pickleball Compete LLC is not responsible for payment errors or disputes beyond what is required by law.

7. Disclaimers

The PicklePot app is provided "AS IS" without any warranties. We disclaim all liability for errors, downtime, data loss, or inaccurate results. Participation in matches or tournaments is at your own risk. We do not control or guarantee organizer conduct, communications, or tournament outcomes.

8. Limitation of Liability

To the maximum extent permitted by law, Pickleball Compete LLC is not liable for any indirect, incidental, or consequential damages. Our total liability is limited to the amount you paid us in the 12 months preceding the claim.
